

Mr. Waldrop and suggest to him that Mr. Riley's criticism be abated. Mr. Hoover also requested Mr. Quinn to communicate with Mr. John Lambert, without referring to the Riley matter, and suggest a story or two which would get a wide publication and would counteract the Riley criticism. Mr. Quinn stated that the first installment of Courtney Ryley Cooper's story "Special Squad" appeared in the New York Daily News today.

Mr. Quinn stated that an article appeared in one of the local newspapers describing how the police had been called during the night by the guard in the Justice building to assist in hunting for an alleged intruder; that the Captain of the Guard today explained the guard had previously become frightened and called the police, and he has recommended the guard's transfer or dismissal. Mr. Hoover requested Mr. Quinn to follow up the matter and if nothing is done to see Mr. Little.

Mr. Quinn advised of the announcement appearing in the Intercollegiate Bulletin of Detroit that SAG Reinecke will appear to speak on "G-Men"; that Edward Lyons had printed in his column a note about the Director's letter to him thanking for interest in field of retirement legislation for Agents; that a letter had been received from Mrs. William B. Maloney of the New York Herald Tribune concerning details of the forum and the time of the Director's speech. Concerning Mrs. Maloney's request that a copy of the speech be forwarded so that it would be available for the press, the Director stated he would take care of this request when he returned.

Mr. Quinn stated that he was holding the flyers sent by Rex Collier. Mr. Hoover stated to hold them until his return. Mr. Quinn advised of Mr. Collier's story appearing in the paper yesterday relative to the finding of the Cohen boy.

Mr. Quinn advised of the letter concerning an N.S.P.A. case received from Mr. Keith and stating that possibly Congressman Cochran should be communicated with in this connection. Mr. Hoover stated to let the matter rest.

Mr. Quinn stated that Mr. Suydam had called again with reference to the Identification Orders requested for the Gang Busters program. Mr. Hoover stated to provide the Identification Orders but to take ample time.

Mr. Quinn advised of the receipt by Mr. Clegg of a letter from Francis Biddle requesting Mr. Clegg to speak at one of the charity meetings since they could not secure the Director. Mr. Hoover stated to have Mr. Clegg reply that his commitments are subject to instructions of the Bureau and suggest that Mr. Biddle communicate with the Director.

Mr. Quinn advised of the receipt of an invitation to the Director to speak at a meeting of the Detective Section of the Association of American Railroads, St. Louis, May 20 and 21. Mr. Hoover stated he had met Mr. Denton Special Agent of the Baltimore & Ohio Railroad who had orally invited him and that he had informed Mr. Denton that he would be unable to accept and Mr. Denton stated they would then like to have Mr. Schilder. Mr. Hoover instructed Mr. Quinn to decline and offer a substitute and if the substitute is accepted to designate Mr. Schilder.

Mr. Tamm stated in regard to the Ballston Bank case that the man being sought in West Virginia has not been apprehended and that man now in custody will be held at least until Monday. Mr. Tamm advised that SAC Jones had apprehended the subject of an I.O. and would authorize a release. Mr. Hoover approved. Mr. Tamm advised that Mr. Connelley would be in Chicago on Monday morning. Mr. Tamm stated no progress is being made in the bond case in New York.

Mr. Hoover stated he would arrive in Washington at 1:15 P.M. on Sunday and would go directly home.

Mr. Hoover stated to tell the Attorney General he would be home on Monday morning.

Mr. Tamm informed the Director of a teletype from the Los Angeles Office concerning an alleged kidnaping threat against Virginia Bruce; that there is apparently nothing about the case. Mr. Tamm advised that concerning the people that have been investigating communist matters, Mr. Hanson states that only the Navy Intelligence people have been active.

Mr. Tamm stated that a request had been made to have Mr. Parsons of the Laboratory testify for the defense in a manslaughter case in Virginia; that the deposition made by Parsons would not be admitted by the court. Mr. Hoover stated that Judge Holtzoff should be consulted about the matter; that the Judge should be informed that we believe Parsons should be permitted to testify but we desire his ruling on the matter.

Mr. Tamm stated that the Attorney General had transmitted a newspaper clipping pertaining to the Senate Munitions Committee hearings concerning disposition of old machine guns by the War Department; that the Attorney General desired to have the Director look into the matter of whether or not these machine guns got into the hands of gangsters and submit the Director's views to the Attorney General. Mr. Hoover stated to have the Field Office examine the testimony and see if there are any leads that can be followed; if so have that done.

Mr. Tamm advised of a memorandum from Judge Holtzoff transmitting copy of a Congressional bill to further reduce immigration and providing for an interdepartmental Board to pass on alien matters and to provide rules and regulations for the procedure in taking of a nationwide official registration and fingerprint record of all aliens in the United States. Mr. Hoover requested that the bill be kept aside for his return.

Mr. Hoover requested that arrangements be made to have Mr. Horn taken on a tour. MEMORANDUM

Conversation of Mr. Tamm with Director.

Mr. Tamm advised of a conference with the Attorney General concerning the investigation for the Supreme Court and that the Attorney General is sending a copy of the report to the Chief Justice.

Mr. Tamm advised of the receipt from Sanford Bates of two original letters addressed to the Attorney General and to Governor Hoffman by Gaston B. Means relative to the Lindbergh case; that Means claims Hauptmann is not guilty. Mr. Hoover stated to have copies of the letters made for Bureau files and then return the originals to Mr. Bates informing him that the contents have been noted and that it is assumed he possibly desires to forward the originals to the addressees. Mr. Tamm stated this would be done tomorrow.

Mr. Tamm advised that one of the suspected bank robbers in the Ballston Bank Robbery had been picked up and that Mr. McIntire had gone to West Virginia to apprehend the other suspect; that the case will probably break in two or three days.

Mr. Tamm advised of a telephone call from Mr. McMahon who desired to talk with the Director immediately to secure the Director's slant on a situation troubling him and also to discuss a matter pending in Miami. Mr. Tamm advised of a local kidnapping at Harrison, Mississippi. Mr. Tamm advised of a news item stating that Justin Hill will participate in a convention March 31, 1936 in Indianapolis under the auspices of the Indiana University Institute of Criminology and Criminal Law. Mr. Tamm advised of a news article stating that the Attorney General has asked the FBI to determine whether Army machine guns sold for junk are leaking into the underworld, also the Criminal Division has been asked to ascertain whether licensing of the junked guns can be required under existing laws. Mr. Tamm advised of news dispatches relative to the discharge of two employees of the U. S. Steamship Inspection Service.

Mr. Tamm stated that the St. Paul Office had inquired if Byron Bolton should be transferred to a place more healthy than the county jail as Bolton is dying of tuberculosis. Mr. Hoover stated to do anything within reason. Mr. Tamm stated he would discuss the matter with Mr. Connelley. Mr. Tamm advised that the New York situation is proceeding without any sensational developments; that Mr. Nathan had informed the insurance people that the Bureau would not be a party to a "buy-back" arrangement.

With reference to the reported kidnaping threat received by Virginia Bruce in Los Angeles, Mr. Tamm advised of a teletype received from SAC Hanson in which he advised that the family has been notified of our office and the telephone number; that the family is not alarmed and they are paying no attention to the threat.

Mr. Tamm advised that Mr. Connelley is going to Los Angeles today at noon arriving there at 7:30 P.M. Mr. Tamm stated that he thought Mr. Connelley should do this as long as he is in Portland in order to look over the Weyerhaeuser and Bremer set-ups there.

With reference to the bank robbery at Ballston, Virginia, Mr. Tamm advised that it looks now as though one of the McDaniels brothers was in on the robbery as well as a man named Harper; that we are trying to locate Harper in order to pick them both up at once.

With reference to the call from [redacted] at Franklin Town, North Carolina, Mr. Tamm advised that the Charlotte office has been instructed to send an Agent there.

Mr. Tamm advised of the articles in the Star and Herald relative to the negro prisoner who was stabbed to death in Lorton Reformatory. Mr. Tamm stated that an Agent is there now ascertaining the details.

Mr. Tamm advised that Agents DiLillo and Thompson are preparing their last reports. Mr. Tamm advised concerning the remarks relative to Colonel Riggs.

With reference to the letter to Walter Winchell, Mr. Tamm advised that the letter is ready for transmittal under today's date. Mr. Hoover asked that this letter be sent to him via Air Mail Special Delivery for his signature.

MEMORANDUM

Conversation of Mr. Quinn with Director.

Mr. Quinn advised of a call from Bob Denton relative to Mr. Hickson who had called at the Bureau in connection with an apparatus he had designed. Mr. Hoover stated that if any further inquiries were received to state that Hickson had called at the Bureau but that the instrument was of no interest of concern of the Bureau and could not be of any value in the Bureau's work.

Mr. Quinn advised of a call from Mr. Rex Collier who stated that the people in New York were not satisfied with the Director's letter; that Mr. Collier wishes to speak to either the Director or Mr. Tolson about the matter. Mr. Hoover stated to have him see Mr. Snydam.

Mr. Quinn advised of receipt of a telegram from Mr. Maury, editor of the Lancaster Eagle, Lancaster, Ohio inviting Director to become honorary national president of the Eagle Club. Mr. Hoover stated to decline in a courteous manner. Mr. Quinn stated that Mr. Egan wished to transfer an accountant, Rollett. Mrs. Hoover stated this would be all right. Mr. Quinn stated that an invitation for the Director to speak had been received from the National Society of the United States Daughters of 1812, for April 27. Mr. Hoover stated to decline and offer a substitute.

Mr. Quinn stated that Mr. McFall had telephoned concerning the fingerprints sent from the Navy Department; that Mr. Quinn had confidentially informed Mr. Merrill relative to the prints received and the percentage of identifications made; that the Navy people had wagered not more than 10 out of the 800 would be identified. Mr. Quinn stated that Mr. Snydam's secretary had called and wanted to send Mr. Ross, editor of the St. Louis Post Dispatch, around at 10 A.M. tomorrow; that Mr. Quinn had approved. Mr. Hoover stated this was all right. Mr. Quinn stated that Mr. Carusi had called in person relative to the Dallas Exposition; that apparently Secretary Roper had spoken to the Attorney General about having the Bureau participate. Mr. Hoover stated that we had already committed the Bureau to San Diego, that we could not run two exhibits and the Dallas matter is at an end. Mr. Quinn advised of Mr. Carusi's request for a new badge. Mr. Hoover stated that he would attend to this matter upon his return. Mr. Hoover inquired as to the status of the San Diego exhibit. Mr. Quinn stated that we had not been officially notified that the \$5,000.00 is ready to spend. Mr. Hoover requested that this matter be followed up, and inform them that we will have to have some definite word.

Memorandum of Telephone Call to Director

MEMORANDUM

Mr. Tamm advised Mr. Hoover of his conversation with Mr. Connelley last night concerning his interview with the Seattle Star. Mr. Tamm stated that the Takoma paper obtained the story from one of the bank employees; that they called Agent Bowling, resident Agent at Seattle and asked him about the story; that Bowling told them that there was not such comment he could make about it and that he stated that he thought they should not print a story which might prove to be unfounded; that Mr. Spears was there when the reporter was talking to Bowling; that Mr. Spears immediately contacted the editor of the Takoma paper and asked him not to publish the story; however the newspaper reporter that got the story was also a representative of a wire service; that while the editor of the Takoma did not publish the story, the reporter put it on the wire and the paper in Seattle picked it up and published it; that the editor told Mr. Connelley that no one had asked him not to publish the story and that hereafter he would not publish any stories of this kind without first obtaining permission of the Portland office.

Mr. Tamm told Mr. Hoover that he thought we had the robbers of the Ballston, Virginia, Bank identified; that the gun has been positively identified and the indications are that two local boys, the McDaniel brothers robbed the bank. Mr. Hoover inquired as to who obtained the information as to who the robbers were and Mr. Tamm stated that a Police officer and the Mayor in Falls Church, Virginia obtained a line on some negro in Virginia who had loaned a sawed off shot gun to two boys who were going rabbit hunting; that they put us in touch with this negro who positively identified the gun as belonging to him. Mr. Hoover told Mr. Tamm to keep this from the Washington Police. Mr. Tamm stated that the boys evidently have been out of Washington for some time living in Maryland, the exact place not known.

Mr. Quinn advised of memo from Mr. Glegg stating Capt. Price of Pennsylvania Highway Patrol had resigned. Mr. Hoover stated to make sure of this before taking him from the faculty as he might be accepting some other state office.

Mr. Quinn advised of the receipt of a letter from Fred Wilson, the City Manager of Phoenix, stating there had been some objection to sending Sgt. Littlefield to the Police School and requesting a letter from the Director. Mr. Hoover stated to have letter prepared for his signature.

Mr. Quinn stated that Rex Collier had called him and inquired if anything had been heard about an article which is to appear in the American Mercury, written by an ex-employee of the Bureau, said article being very critical of both the Bureau and the Director. Mr. Quinn stated Mr. Collier has promised to ascertain the name of the person who is writing the article. Mr. Quinn stated he would follow this up.

Mr. Quinn advised of a memorandum from Mr. [Name] suggesting that mail addressed or routed to the Bureau for which an addressee is unable to be located, be routed through the Department mail room instead of back to the Post Office Department. Mr. Hoover stated to find out what this is about. In regard to the wire from Mr. [Name] of Citizens Association of Jamestown, Penna. requesting a speaker to substitute on their program on February 27, Mr. Hoover stated to refuse this. Mr. Quinn advised of receipt of a wire from the Director of the Town Hall of New York City asking the Director to speak on March 26. Mr. Hoover stated to send a wire that he was out of the city but that his commitments preclude his speaking in March. Mr. Quinn stated he had arranged a tour to be conducted for a party of friends of Congressman Hollister of Ohio. Mr. Quinn advised of a wire from Mr. Wakefield, the Director of Public Safety at Louisville requesting to talk to the Director upon his return, and asking the Director to wire him of convenient time.

Mr. Quinn read the letter which the Attorney General had sent to Mr. Francis Biddle. Mr. Quinn stated SAC Nathan had telephoned and inquired if Agent Witzsimmons could complete some leads in Miami in the Gremer case that he could introduce the new resident Agent to his contacts there. Mr. Hoover stated this could be done.

Mr. Quinn stated he had called Mr. McFall who stated to include the amount in the Deficiency Bill and then if it is granted the deficiency amount may be cancelled. Mr. Hoover stated to have the Chief Clerk's office prepare such a deficiency report for review on Monday.

Mr. Quinn stated that Congressman McMillan had telephoned and requested an application blank; that Mr. Quinn had informed him that the blank would be sent but that due to the condition of the appropriation it would be a waste of time; that the request for the application blank had then been cancelled.

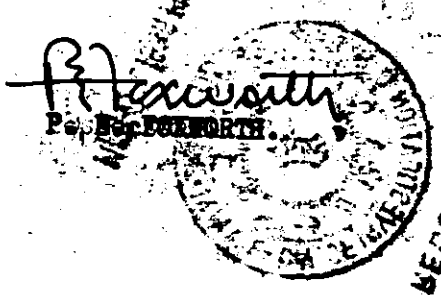

MEMORANDUM

Telephone Conversation of Mr. Tamm with Director.

Mr. Tamm advised that Harrison, County Attorney at Leesburg, Virginia, telephoned last night to advise that he was making a formal request for the assistance of the Bureau in the Utterback case. The Director inquired if the Bureau had any jurisdiction. Mr. Tamm advised the Bureau had no jurisdiction and he had so informed the County Attorney. The Director stated that if there is any laboratory work to be done the Bureau will be glad to do it. Mr. Tamm stated he had so advised the County Attorney. The Director stated that if Colonel Gates calls to inquire if the Bureau is in the case to inform the Colonel that the Bureau has offered to the County Attorney the full facilities of the laboratory and the fingerprint division but that the Bureau can perform no investigative work as there is no violation of a Federal statute. The Director stated that the same position had been taken in the murder case in Minneapolis. Mr. Tamm stated that Mr. Waldrop had telephoned and said that the District Attorney in that region of Virginia indicated that the Bureau was in on the case as the attorney had a card of Mr. Dunn of the Department of Justice. The Director stated that it might be former Agent J. E. P. Dunn; that Mr. Whitley had advised that he is in New York on some matters. The Director stated to indicate if anyone calls that this person is not in the service, and to ascertain if possible if someone is presenting himself as an Agent.

Mr. Tamm advised that Mr. McMahon had telephoned and complained that he had not yet received a report on the Tamm case; that he, Mr. Tamm, had informed Mr. McMahon that as soon as a report was received containing information pertinent to the Department in corresponding with the United States Attorney it would be forwarded. The Director stated that if Mr. McMahon made further complaints to refer him to the Director.

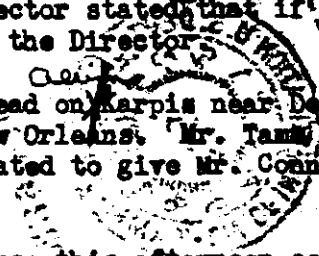

Mr. Tamm advised that no word had been received today from Mr. Keith. The Director stated to cable Mr. Keith asking him to advise what the situation is there particularly with reference to the publicity; and to suggest that Mr. Keith get over to the French press the thought that a capable and efficient law enforcement officer never discloses or discusses what he proposes to do in a case and that is the policy followed by the F.B.I. which is the reason he, Mr. Keith, cannot give details to the press.

Mr. Tamm advised of the situation concerning the ^{cut} Barry woman in Toledo and the Goldstein woman in Little Rock. The Director stated to keep the Chief of Police and the Chief of Detectives of Hot Springs in mind for possible prosecution later.

Mr. Hoover telephoned from New York and stated that they were leaving by plane at 3:45 P.M. Washington time; that the plane will land in Washington. Mr. Hoover instructed Mr. Tamm to have Mr. Glavin meet them at the airport; that neither he nor Mr. Tolson will get out of the plane. Mr. Hoover stated that he wanted Mr. Glavin to bring to the plane his pearl handle revolver and Mr. Tolson's revolver together with the memorandums and papers in a brief case. Mr. Tamm suggested that the plane land in Baltimore and Mr. Hoover stated that Baltimore might draw more attention than Washington. Mr. Hoover stated that if the plane goes to the hangar for oil, Mr. Glavin can meet them there. Mr. Tamm stated that four men getting out of a large plane would draw less attention than two men and Mr. Hoover stated to have Mr. Glavin prepare himself to go along with them. Mr. Hoover instructed Mr. Tamm to telephone Mr. Magee at New Orleans and tell him not to let anybody know of these arrangements except Mr. Connelley. Mr. Hoover told Mr. Tamm not to let anyone here at Washington know about this matter, except Mr. Quinn and Miss Gandy. Mr. Hoover stated that he wanted Magee at the airport around 8:30 or 9:00 P.M. and park the car. Mr. Hoover stated that a reservation should be made at one of the leading hotels there for a room and parlor in his, Mr. Magee's own name or Mr. Glavin's name. Mr. Hoover stated that it might be well to call Mr. Connelley rather than Magee and advise him of the situation. Mr. Tamm suggested that Mr. Hoover have some money to take care of any contingency and Mr. Hoover told Mr. Tamm to have Miss Gandy give Mr. Glavin five hundred dollars from his account, Mr. Hoover's account. Mr. Hoover stated that he would like to leave one of his suitcases off at Washington and instructed Mr. Tamm to have someone there with Mr. Glavin to take care of it. Mr. Tamm stated that he would be at the airport to see that everything is handled properly.

Mr. Tamm advised me that the New York Police sent out an alarm yesterday according to the papers that Karpis had been seen in Cambridge, New York, yesterday. I told Mr. Tamm that I had not seen this. Mr. Tamm stated that he had called Agent Doherty in Buffalo and instructed him to check on the above. Mr. Tamm advised me of the developments in the Dainard case. Mr. Tamm said that Judge Holtzoff had called and given him the developments of the Catherine Klein relief bill. Mr. Tamm advised me about an article in the Washington Herald this morning to the effect that the four major U. S. Agencies will conduct a survey of the attack by strikers on ship operators and that the Justice Department is one of the Agencies in the group above mentioned. Mr. Tamm informed me of a local impersonation case in which a man posed as a G-man and supposedly arrested two girls and took them to a third rate hotel here and criminally assaulted one of them. Mr. Hoover telephoned from New York City and Mr. Hoover stated that he had reservations on the night plane for New Orleans; that Mr. Whitley is trying to make arrangements for a chartered plane which will probably leave within the next hour. Mr. Hoover stated that if the plane stops in Washington he would like to see some of the memorandums and background for him. Mr. Hoover stated that if the plane stops at Mobile he will have a car meet him; that he will keep in touch with the New Orleans office by radio in order to be advised of any developments or excitement. Mr. Tamm called Mr. Hoover's attention to possible interception of radio messages by other people. Mr. Hoover stated that if the plane arrives in Washington without it being known he will go on into New Orleans. Mr. Tamm stated that New Orleans is about sixty five miles from Mobile, that is, by air mileage. Mr. Hoover stated that he would have Magee make reservations in New Orleans for him, but not under his, Mr. Hoover's name.

Mr. Tamm advised that Grace Holdstein has been with Connelley and after three hours questioning, she has given the exact address in New Orleans. Mr. Tamm stated that all that has been recommended to her is that we would definitely recommend to the U. S. Attorney that she and Carrie Morris, who is the prostitute with Fred Hunter, not be prosecuted for harboring; that she also wanted us to promise that her family would not be prosecuted for harboring. Mr. Tamm stated that we do not have a case against them and she was promised this. Mr. Tamm stated that she does not want any money and Mr. Hoover stated that we would pay her anyway. Mr. Tamm advised that the apartment is on a boulevard on a very busy corner; that it is a three story apartment house with only one apartment on each floor of the building; that Karpis is on the first floor; that Mr. Connelley is out now looking the place over. Mr. Hoover was advised that there are twelve men in New Orleans; that Brantley, Buchanan and Hurt were going over from Dallas. Mr. Hoover stated that if Connelley wanted any more men, Glavin and Gurnea could board the plane when it stops at Washington. Mr. Tamm was instructed to have Glavin and Gurnea stand by.

Mr. Quinn advised that he had been unable to get in touch with Mr. Gardner of Detroit. The Director stated that he would place the call again tomorrow morning through the Bureau switchboard when he called the office.

Mr. Quinn stated that Mr. Suydam had telephoned and stated an agreement had been made with the National Broadcasting Company that they were to put on a broadcast concerning the apprehension of Karpis; that the NBC now wishes Mr. Hoover to speak for a minute on the radio tonight. Mr. Hoover told Mr. Quinn to tell Mr. Suydam that he, Mr. Hoover, had told the NBC people that they should prepare the material in advance as the Bureau would not have time for it when the case actually broke; that the NBC procrastinated and now he, Mr. Hoover, hasn't the time to give to it, and further that he will be flying tonight until late and for this reason also, he could not make the broadcast.

Mr. Quinn stated that Mr. Dougherty who is taking the place of Mr. Stanley Carroll will write a story along the lines Mr. Hoover wished; that Mr. Waldrop had been contacted and the cartoon will be prepared; Mr. Quinn stated that Senator Black's office called and wished Mr. Hoover to accept the invitation for the Alabama Peace Officers meeting and Mr. Hoover stated he had declined this invitation. Mr. Quinn advised of Mr. Francis Connor's call to Mr. Aldrich. Mr. Hoover stated to tell Mr. Connor he could indicate if possible, that the case was solved in spite of the efforts of other governmental agencies to ruin it. Mr. Quinn advised of the visit of Arthur Train, Jr. Mr. Quinn stated Rex Collier was in and was given the general releases and seemed put out over something. Mr. Quinn advised of the call of Mr. Herbert Corey. Mr. Quinn advised of the call of Mr. Fred Buchholz to Mr. Steady concerning the desire of Freddie Miller, the fighter to meet the Director. Mr. Quinn stated he would suggest to Mr. Buchholz to bring Miller down to the Bureau some time next week.

Conversation of Mr. Quinn with Director at New York.

Mr. Quinn advised of his conversation with Mr. Suydam re the proposed broadcast by N.B.C. and stated that Mr. Suydam advises he is trying to contact Mr. Lundall. Mr. Hoover stated to tell Mr. Suydam that he, Mr. Hoover, would be very glad to meet the N.B.C. officials in Washington on Tuesday morning; that he would be glad to make available to them the data upon which they could predicate a broadcast provided it is done with the assistance of Courtney Ryley Cooper; and provided further that neither the Director nor any other Bureau official make any radio statement inasmuch as this would be undignified. Mr. Hoover stated he would not talk to the N.B.C. officials in New York and neither had he allowed any of the newsreels to make any pictures. Mr. Hoover also stated to tell Mr. Suydam that the Director would want to have the benefit of Mr. Suydam's judgment in any program which would be submitted for approval. Mr. Hoover stated it would be all right to allow the N.B.C. to state the facts were taken from the files of the Bureau.

Mr. Quinn advised of his conversation with Agent McKee regarding Karpis who admitted his guilt in both the Hamm and Bremer cases. Mr. Hoover stated to ask Agent Stein to find out if Karpis would plead guilty to two indictments with the sentences running concurrently. Mr. Quinn advised of Karpis' modus operandi in obtaining a haircut; of his knowledge of the Bremer trial; and of his statement he would not talk about his women. Mr. Quinn further advised that Karpis stated he had not been in Chicago since 1934; that he expects his parents to come up to see him but that he does not want them to come and wishes to send them a telegram so instructing them. Mr. Hoover stated the wire could be sent. Mr. Quinn stated that Karpis has mentioned his agreement with Mr. Hoover that he would either tell the truth or not speak at all; and also advised of Karpis statements about the Delaney woman and the boy.

Mr. Hoover told Mr. Quinn to send \$1,000 by wire to Mr. Connelley at Cleveland.

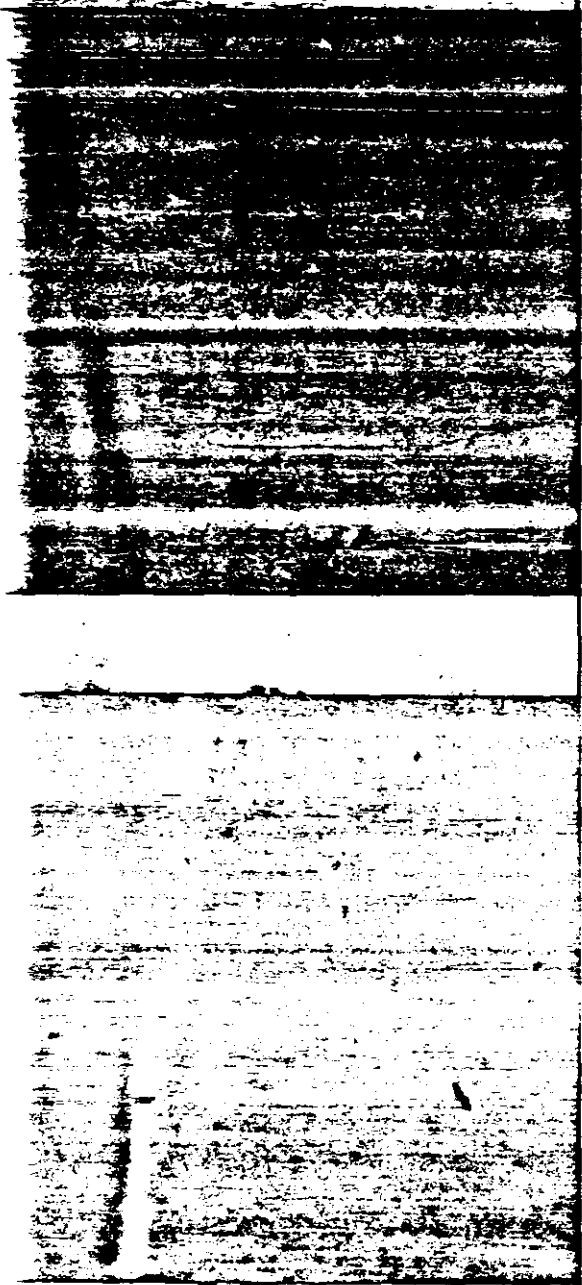

Mr. Tamm stated he had talked with Magee at New Orleans and that he, Mr. Tamm wished to send Agent McIntire to New Orleans to question Hunter and the girl. Mr. Hoover stated it would be all right to send Agent McIntire but the girl should not be held any longer and to this end had advised the New Orleans office to release her and pay her railroad fare out of there. Mr. Hoover stated that he told Mr. Connelley to tell this to Magee and to also instruct him to not arraign Hunter if he is talking tomorrow or has not made a full statement but to hold him until he does make a full statement in which he should be arraigned and required to post a \$200,000 or \$100,00 bond; and that Hunter should be held until Agent McIntire arrives.

The Director inquired if the post-office matter at Toledo had been started. Mr. Tamm advised that the reports would be in tonight.

Mr. Tamm advised of the receipt of a wire from SAC Fletcher advising of the release of an Associated Press dispatch concerning Grace Goldstein. Mr. Hoover requested Mr. Tamm to get word of this matter to Mr. Connelley immediately and inform him that the Director suggested the desirability of Mr. Connelley's going to Hot Springs to quiet down Akers or whatever other action Mr. Connelley thinks he should take.

Mr. Tamm advised of the apprehension of a fugitive in Charlotte and the Director authorized giving the facts to the press there.

Mr. Tamm advised of the disposition of Long in Chicago who had been turned over to the Chicago Police. The Director stated that Mr. Ladd could give the release to the press and the release could at the same time be sent to Colonel Gates.

Mr. Tamm advised of the possible continuance of the case involving Randall and Adams. The Director stated this should be blocked if possible.

Telephone Conversation of Mr. Quinn with Director.

Mr. Quinn advised the Director of Mr. Stanley Carroll's call this morning and his inquiry as to whether or not the Director would make any comment if a statement was issued by Postmaster General Farley, and of Mr. Carroll's proposed interviews with Senators and Congressmen concerning pensions.

Mr. Quinn advised that Joe Cronin and Al Schacht would visit the Bureau tomorrow morning. The Director approved having a special tour for them.

Mr. Quinn advised that Mr. Egan was leaving for Atlanta to consider the matter of space. The Director stated he was reluctant to relinquish private space to take space under the control of the Procurement Division who would place their own elevator operators and guards in the building. The Director stated he wanted twenty-four hour elevator service and adequate guard service; that the investigative units of the W.P.A. and the Interior Department would also probably be located in the same building. The Director requested Mr. Quinn to discuss the matter with Mr. Egan.

The Director also requested Mr. Quinn to arrange to have Mr. Edwards work on applicants the next two week-ends if possible.

Mr. Quinn advised of the call from Mr. Turner who desired to have Mr. Listerman given authority to discuss the Mahan case; that Mr. Quinn had advised no information could be given except by the Director. The Director requested Mr. Quinn to get in touch with Mr. Listerman and inform him that the Director does not want him to say anything, which applies to Mr. Spears also.

Mr. Quinn advised of the call of Senator Ashhurst's secretary relative to securing data for a speech by the Senator. The Director requested Mr. Quinn to work up some material using as a basis the memorandum prepared at the time of the Senate cut in the appropriation and to have Mr. Tamm assist in preparing any other material which should be ready for Mr. Tolson Monday morning.

Mr. Tamm advised the Director that Courtney Ryley Cooper desired to get a story out by tomorrow on paroles based on the Weyerhaeuser case. Mr. Tamm advised that the memoranda to the Attorney General on the post office matter are ready; also the memorandum for the Director on the Toledo Police Department. Mr. Tamm informed the Director briefly of these memoranda.

The Director stated that a letter had been received from Reyer concerning a complaint that one of the Bureau men had used profane epithets against one of his men subsequent to the arrest of Karpis in New Orleans. The Director stated that Mr. Connelley believed the incident had occurred at Karpis' apartment after the arrest when an officer tried to enter the apartment and was refused admittance by the Bureau men. The Director instructed Mr. Tamm to get this letter and then communicate with New Orleans or wherever the Agents now are who were involved, and ascertain the facts so that an answer can be made to Reyer.

Mr. Tamm advised of the receipt of a memorandum from Justin Miller protesting over the fact that the Bureau had been investigating as an impersonator one Henry E. Edmunds, Regional Field Supervisor of the Study of Release Procedures; that such an investigation had been made at the request of Mr. Keenan who said that Edmunds was not on the Department payroll. The Director stated to send a memorandum to the Attorney General stating there had been received a memorandum complaining of the actions of our Agents in conducting this investigation; that in order that the Attorney General may be informed of our action in this matter Mr. Keenan specifically requested this investigation informing the Bureau that there was no one on the Department payroll by that name; that consequently we complied with this request as we naturally would with the request of the Assistant Attorney General and therefore it seems the Bureau is not to blame for the action taken in this matter.

Telephone Conversation of Mr. Tamm with Director.

Memoranda on Telephone Calls

The Director telephoned from Philadelphia and Mr. Tamm informed him that yesterday a teletype had been received from SAC Dowd concerning William H. Lemmon, Mail Fraud, in which case the Bureau had conducted no investigation, to the effect that the case was called in Indianapolis yesterday and Lemmon failed to appear; that the United States Attorney asked the Bureau to locate the missing person. Mr. Tamm stated that the Bureau had wired Dowd in accordance with policy in such cases that the Agency that had conducted the substantive investigation should locate the fugitive, which is the Post Office Department. Mr. Tamm stated that a teletype had been received today from SAC Dowd concerning an Associated Press statement that is to be printed today allegedly quoting United States Attorney Val Nolan. The Director stated to make certain that SAC Dowd makes no statements, and requested Mr. Tamm to prepare a memorandum for the Attorney General outlining the facts as related to the Director, that the case was handled by the Post Office Department and the Bureau was asked to locate the fugitive; that in line with the well accepted policy that all Agencies seek their own fugitives the Agent in Charge at Indianapolis was advised that the matter there must be handled by the Post Office Inspectors; that information has been received that the Associated Press is preparing to quote as indicated and that obviously it would seem to have been improper for the United States Attorney to make these comments if in fact he did, as indicated by the Associated Press; that not only has the policy referred to been one of long standing but has been an imperative policy during the last year by reason of the inadequate appropriation with which the Bureau has had to function; that the Bureau has not been able to assume work that should be done by other Departments. The Director requested that this be written up so that it could be read to him when he called in Thursday morning.

Mr. Tamm inquired if a memorandum on the Lipsey case should be prepared for the Attorney General. The Director stated that such a memorandum had been sent.

Mr. Hoover telephoned from New York City and Mr. Hoover stated that he was unable to reconcile the figures relative to the amount of money recovered in the bank cases. Mr. Hoover stated that he, Mr. Tamm, had Mr. Keith listed as bringing back four hundred and forty thousand dollars; that there was three hundred and fifty thousand listed as recovered in the United Trust; that seventy thousand had been located where the numbers had been changed. Mr. Hoover stated that this totalled up to eight hundred and sixty thousand and inquired of Mr. Tamm where he obtained the eight hundred and sixty five thousand. Mr. Tamm stated that he would check on this. MEMORANDUM

RE: Conversation of the Director
and Mr. Quinn.

Mr. Hoover telephoned from Philadelphia and Mr. Quinn advised of the letter received yesterday from former Special Agent W. A. Cuff who is now a member of the Ohio Board of Parole; that Mr. Nathan delivered a speech in Cleveland and Mr. Quinn read to Mr. Hoover the article in the Cleveland Plain Dealer quoting Mr. Nathan under date of May 19, that Mr. Nathan stated substantially the quotation is correct, however, he does not remember the exact words; that Mr. Nathan did not have any particular board in mind but that he did vigorously attack the parole system. Mr. Hoover instructed Mr. Quinn to prepare a letter for his signature to Mr. Cuff advising Mr. Cuff that his letter has been received; that Mr. Nathan upon being questioned, stated that his quotation was substantially correct; that if he will note that Mr. Nathan did not mention any particular board by name; that if anyone wishes to take exception to that as applicable to some local condition, it is not within our province of jurisdiction; that it is a fact that the parole system as administered by many of the states is a national scandal and that in Mr. Nathan's address, while he did not mention any particular state, any person who feels that it is applicable to their particular condition is, of course, it is their privilege to accept it as such. Mr. Hoover stated that he feels that the public is sufficiently intelligent to be able to distinguish between the bad and the good and if they are able to indicate and to judge those parole boards who are trying to do an honest job and those who are not, those parole boards who are trying to do an honest job should have a clear conscience.

Mr. Quinn advised Mr. Hoover of a personal and confidential letter addressed to him from SAC Thompson, stating that he, Thompson, has been confidentially advised that during 1935 Glavis was instructed by Secretary Ickes to conduct an investigation relative to candidates holding positions in the government. Mr. Quinn read the above letter in its entirety to Mr. Hoover. Mr. Quinn informed Mr. Hoover that Thompson does not state in the letter where he secured the information contained in the above letter. Mr. Hoover advised Mr. Quinn to ascertain this fact from Thompson. Mr. Hoover told Mr. Quinn to write a strictly confidential letter to the Attorney General and state that with reference to my confidential talk with you, Mr. Hoover, concerning certain investigative activities of Mr. Glavis, I desire to advise you of the following and then he, Mr. Quinn, should give the following information, that is, the information contained in the above letter.

Mr. Hoover telephoned from Philadelphia and Mr. Tamm advised of information received from Mr. Keith relative to the bond case; that ~~Klein~~ will appear in New York when his sentence has been served over there. Mr. Tamm stated that Mr. Keith has the bonds. Mr. Hoover stated that he thought this would make a good news story to give out that our man in France has the half million dollars worth of bonds. Mr. Tamm stated that Mr. Keith further advised that ~~Oswald~~ will arrive in New York on Sunday. Mr. Hoover instructed Mr. Tamm to call Mr. Keith today and find out just what the status is. Mr. Tamm was instructed to send to Mr. Hoover at the Hotel New Yorker a short memorandum of facts on this case. Mr. Tamm was further advised by Mr. Hoover that it may be a good idea for him, Mr. Hoover to give this out at New York tonight or tomorrow. Mr. Hoover told Mr. Tamm to inquire of Mr. Keith why he has allowed this man to have his picture taken with him. Mr. Hoover stated that he was leaving for New York City at 1:27 P.M., Washington time; that he will be at the New Yorker at about 3:30 P.M., Washington time. Mr. Tamm stated that when he talks to Mr. Keith he will have Mr. Keith make tentative arrangements with the French Police so that if we need ~~Klein~~ here, they will be able to send Klein over here to us. Mr. Tamm was instructed to send the memorandum by special delivery.

With reference to the situation in Indianapolis yesterday, Mr. Tamm read to Mr. Hoover the memorandum which he had prepared for the Attorney General. Mr. Hoover advised Mr. Tamm to change the memorandum to read "long established policy" instead of well established policy and to include "long established policy laid down by the Department for the Bureau". Mr. Hoover stated further to include "since that investigative agency was in full possession of all detail facts concerning the defendant fugitive". Mr. Hoover telephoned from New York City and with reference to Thomas H. Robinson, Jr., Mr. Tamm advised that Robinson stayed at the Hotel New Yorker under the name of Thomas Wakefield in room 712 from about October 15, 1934 until Christmas. Mr. Tamm advised of several other aliases used by Robinson while in New York City and also furnished Mr. Hoover with the names of several other hotels. Mr. Tamm advised that this information was according to Robinson's statement which was verified by the interview which Agent Bugas had with Jane Hughes. Mr. Tamm advised of the receipt of the lengthy letter from Mr. Whitley today of Agent Bugas' interview with Jane Hughes. Mr. Hoover stated that he would like to have Mr. Whitley send a copy of the letter to him at the hotel.

With reference to the investigation being conducted by Mr. Nathan in New York City, Mr. Hoover inquired if there was anything to substantiate the charges and Mr. Tamm stated that he doubted it. Mr. Tamm stated that Mr. Nathan has to interview several Agents in the Jacksonville office; that Mr. Nathan is making a speech in Baltimore on Thursday night and that he thought he would go to Jacksonville immediately thereafter to finish his inquiries. Mr. Tamm suggested that Mr. Nathan come through Nashville and checked the reported leak there and Mr. Hoover stated this would be all right.

Mr. Tamm advised Mr. Hoover of the Avery Simons matter in Los Angeles relative to the removal hearing. Mr. Hoover instructed Mr. Tamm to ascertain the name of the Judge out there. Mr. Hoover instructed Mr. Tamm to prepare a memorandum for the Attorney General with his signature pointing out the attitude of the U. S. Attorney and his attitude over the fact that we held this man incommunicado and did not immediately arraign him and then point out that when the case did come to trial, the Federal Judge commended our men for what they did.

With reference to the matter that Finley worked on for several years, the Standard Oil Case, Mr. Tamm advised that the Government is going to try and collect from the Standard Oil Company the value of all the oil and gas that the Standard Oil Company produced on this piece of questioned property; that they want to use Finley on it and Mr. Hoover stated that this would be all right.

Mr. Tamm advised Mr. Hoover that he might see something in the paper about an alleged kidnaping case around St. Paul and Grand Forks, North Dakota and Mr. Tamm stated that it was a liquor hi-jacking case.

RE: Director's conversation with Mr. Quinn.

Mr. Hoover telephoned from New York City and stated that Mr. Nathan has left New York and will arrive in Washington at 6:40 P.M. today.

Mr. Quinn advised of the call from Mr. Keenan who called this morning and stated that everything was going along all right; that he would be out of town Monday and Tuesday and that it would be well for him; Mr. Hoover to watch things during those two days; that Mr. McKellar has agreed to withdraw his objections to the Retirement Bill. Mr. Quinn stated that Mr. Keenan called a little later and advised that he had received a call from Mr. Frank C. Walker, a close friend of President Roosevelt, had committed and wanted him, Mr. Hoover, to speak at Wilkes-Barre, Penn., before the Mercantile Association on June 22, 1936. Mr. Hoover stated that his commitments would not permit him to do this and to advise them accordingly. Relative to the Banishes Club, Mr. Hoover instructed Mr. Quinn to contact Mr. John Lambert's office and have them tell him that he, Mr. Hoover, finds that he will be able to speak before the Banishes Club on June 18, 1936 if that will be convenient and agreeable for them.

Mr. Quinn advised of the call from Mr. Jack McFall this morning relative to the Stolen Bond Cases and his friend who had jewelry stolen from him. Mr. Hoover instructed Mr. Quinn that that we would take care of the matter. Mr. Hoover instructed Mr. Quinn to contact New Jersey and have the investigation started.

Mr. Quinn advised of the telegram received from Colonel Shingleton relative to advice about applying to the position in New Jersey and asking for an answer. Mr. Hoover instructed Mr. Quinn to call Colonel Shingleton and tell him that he was acting and that the telegram was received in the Director's absence; that Colonel Shingleton should be advised that he Mr. Hoover could not be reached for several days; that if Colonel Shingleton inquires of him, Mr. Quinn what he thinks about it, to tell him there will be no harm in his making application; that he, Mr. Quinn, should tell Colonel Shingleton that Mr. Hoover will do anything he can.

Mr. Quinn advised of his conversation with Mr. Lester relative to his speech before the Toledo Police Department and his talk with Ray Allen.

Mr. Quinn advised of the call from Mr. Camp in Congressman Ramspeck's office relative to the Retirement Bill heading the calendar. Mr. Hoover stated that he would take care of this through his contact on the Hill when he returns.

Mr. Quinn stated that MacFarland wants three days leave and Mr. Hoover stated this would be all right.

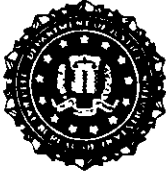

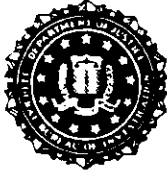
