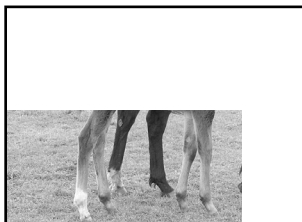

If you wish to have overnights faxed or e-mailed directly to you, contact the racing office.

Rules of racing adopted by the California Horse Racing Board govern all races conducted by the Bay Meadows Racing Association. A copy of these rules is available at the Racing Office or the C.H.R.B. (Hours are from 7:00 A.M. until 3:30 P.M. on race days. Closed from 12:00 to 1:00 P.M. for lunch).

In all overnight races post positions will be drawn for no more than twelve (12) horses. In all stakes races post positions will be drawn for no more than fourteen (14) horses. (For certain races these field sizes may be reduced to insure proper safety standards.)

In all overnight races (including overnight stakes races), with more than eight betting interests, trainers may declare out to that number by the specified scratch time, such practice to be determined by lot if necessary. Declarations below eight may be made only by permission of the Stewards. Scratch time is 9:00 A.M. the race day prior to the race. We will draw no more than fourteen (14) horses for any race (including also eligibles). All scratched horses will remain on the program.

“Quick Official” allows a race to be declared official immediately after the running of the race. The betting public is protected by allowing potential objections by the jockeys to be communicated via two-way radio between the Outriders and the Stewards. Owners and trainers may claim objection by telephone.

All horses placed on the Stewards' List, Veterinarian's List, Starter's List or Schooling List, will be posted on the bulletin board at the Racing Secretary's office and will not be permitted to enter until they have been taken off and approved to start.

## **Paddock Judge:**

**SCHOOLING AND BLINKER CHANGES:** Trainers who request a change of blinkers must first secure permission from the Starter who will certify that the horse has broken from the gate with or without blinkers. This certification does not necessarily mean that the change of blinkers will be allowed. The Paddock Judge or Stewards will be the final authority as to whether or not the change of blinkers will be allowed. Blinker changes must be made at the time of entry and noted on the overnight entries. All horses which have never started must have approval from the Starter before they will be accepted. Permission to school in the Paddock during races may be obtained from the Paddock Judge.

**CHANGE OF EQUIPMENT:** Permission to change equipment must be secured at the time of entry and blinker and nasal strip changes must appear on the overnight. The Paddock Judge will be on duty at the Racing Secretary's office for this purpose until closing of entries each day all horses will carry their equipment to the post.

To work horses before the first race, trainers must receive permission from the Racing Office the day of the intended work.

## **INFORMATION:**

All horses without current racing records, or that have been off the tracks in training, must have satisfactory works recorded before being permitted to start. Horsemen are advised to notify the clockers to insure that works are recorded.

By Order of the Board of Stewards

**All trainers are responsible for keeping soiled straw clean from debris such as shavings, string, twine, wire, rubbish, bottles, cans, etc. This policy will be strictly enforced and will result in the loss of stalls.**

## **ATTENTION HORSEMEN:**

Retroactive purse changes and bonus payments will not be considered for eligibility, allowance or in any computation of earnings. Earnings reported in the Daily Racing Form will be used for the purpose of determining eligibility allowances and preference.

## **REGISTRATION OF HORSES:**

Attention Owners and Trainers: In compliance with a directive from the California Horse Racing Board, foal certificates must have proper ownership displayed on the back in order to be eligible for registration and racing. After horses have been registered with the Racing Secretary, listing their owners, no horse will be transferred (unless claimed at this meeting) without permission of the Stewards who will require a notarized bill of sale from the registered owner.

## MINIMUM WORKOUT REQUIREMENTS:

The following workout requirements must be met to race at Bay Meadows. Please be advised that the trainer will be held responsible for workouts being recorded under the correct name by the official clocker. NO WORKS will be accepted unless from the official clocker or his/her representative. Check the works as being recorded BEFORE entering. Those horses which do not conform to the minimum requirements will be scratched. Penalties may be imposed as needed to insure compliance.

### TWO-YEAR OLDS:

1st time starters in races 2 furlongs; three works, one of which is at least 1/4 mile and a gate ok; Races under 6 furlongs (not including two furlongs); three works, one of which is at least 1/2 mile and a gate ok; 6 furlongs or over; three works, one of which is at least 5/8 mile and a gate ok.

### THREE YEAR OLDS AND UPWARD:

**1st time starters:** three works: one of which is at least 5/8 mile and a gate approval.

**Non-Starter for:** Over 30 days: one work at least 3/8 of a mile within those 30 days.

**Over 60 days:** Two works; one of which is at least 5/8 mile or two 1/2 mile works, with one of the works being within the past 30 days

**Over 90 days:** three works, with at least two works during the last 60 days, one of which is at least 5/8 of a mile or both being 1/2 mile, with at least one of the works being within the past 30 days.

Horses eased or placed on the Stewards' list for poor performance or beaten 30 lengths or over in last start, without cause, will be required to show a 5/8 mile work since that race except for two-year-olds running less than 5/8 of a mile, who will be required to work race distance.

Horsemen seeking to enter a horse not meeting the workout criteria must obtain permission of the Stewards prior to entry.

Imported Horses: The workout requirement will be waived for horses entering in a stakes race within seven days of clearing U.S.D.A. quarantine, provided that the country of origin's racing jurisdiction has no provision for timed workouts.

## SHIPPING REQUIREMENTS:

Horsemen shipping to Bay Meadows are reminded of the following five key requirements for running a horse at Bay Meadows:

1. Lasix - Official Bleeders Certificate
2. California Owners and Trainers License
3. Current Coggins Test\*
4. California Workers Compensation
5. Foal Certificate Papers

6. New Horses arriving from Colorado, Idaho, Montana, Nebraska, New Mexico and Utah must have a negative test for Vesicular Stomatitis before entering any CHRB enclosure.

\*Per CHRB directive 13-92: Prior to arrival at Bay Meadows, all horses arriving from out of state MUST have a current, (within six (6) months) negative Coggins test. If a certificate of proof is not available, a blood test of the horse must be performed within 36 hours of arrival and a negative Coggins test certificate must be delivered to the Racing Secretary within 72 hours of arrival. Horses not in compliance cannot race or train and must be shipped out within 72 hours if a current negative Coggins test is not produced. Horses shipped in to race from unapproved auxiliary stabling must be on the grounds at Bay Meadows Race Track 24 Hours prior to post time. (CHRB Rule 1588i)

Trainers shipping in to race and not using the Transit Barn, must indicate on the Arrival Card the Barn and Stall location of their horse(s).

## IDENTIFICATION:

No horse shall be permitted to start that has not been fully identified. Horsemen should make every effort to have the registration papers of every horse entered at this meeting on file in the Racing Secretary's office before or at the time such entry is made. If the papers of a horse have been lost or destroyed, arrangements can be made through the Horse Identification Bureau to obtain duplicates. Determination of the true sex of a claimed horse shall be the sole responsibility of the claimant, and mistakes in that regard printed in the official program or elsewhere shall not be considered basis for invalidating the claim.

## **CALIFORNIA'S INCENTIVE PROGRAMS: IT PAYS TO BREED AND OWN A CALIFORNIA-BRED**

In 2004, the breeders and owners of California-bred Thoroughbreds and the owners of California-based stallions received almost \$12 million in premiums through the California Incentive Program. In addition, special racing opportunities afforded California-breds in 2004, by the race-per-day rule at California tracks, provided more than \$16 million in purses for races restricted to California-breds.

As a result of legislation amended in 1996, total monies available for incentive awards are distributed as follows: 10% to the California-bred race fund; a 20% bonus on the winner's share to the owner of a California-bred thoroughbred horse conceived by a registered eligible thoroughbred stallion that finishes first in an open qualifying race, and a 10% bonus on the winner's share to the owner of a California-bred Thoroughbred horse that finishes first in an open qualifying race that was not conceived by a registered eligible thoroughbred stallion. The tracks are adding an additional 10% for Cal-Bred winners of allowance races making the bonus 30%. A qualifying race is all non-claiming races, excluding stakes, with a purse of at least \$15,000, as are open claiming races with a purse of at least \$21,500 at this meeting. After these deductions 75% of the remainder to be paid as breeder awards, and 25% of the fund to be paid as stallion awards. The legislation also calls for owners' awards to be distributed at the same time as the purse, and breeder and stallion awards to be paid once a year, and 2005 awards will be paid during March, 2006.

The breeder of a registered California-bred Thoroughbred will receive a pro-rated share of total monies available for breeders. These awards are payable for finishing first, second, or third in any race run in California or in a graded stakes outside California, but within the United States. The owner of a registered California-based stallion will receive a pro-rated share of monies available for stallion owners based upon the earnings of the stallion's California-bred or California-conceived progeny from qualifying wins in California and also for finishing first, second, or third in all stakes within California and graded stakes outside California, but within the United States.

The California-bred race fund will provide for the promotion of California-bred Races and to provide for or supplement purses for California-bred races.

## CALIFORNIA'S INCENTIVE PROGRAMS IT PAYS TO BREED AND OWN A CALIFORNIA-BRED:

Having Trouble Understanding California's Incentive Programs?  
Then Read on for a Better Understanding of Monies Available  
for Owners of Cal-Bred Horses competing in Open Races.

### CTBA-TOC Allowance & Overnight Stakes Program.

Purse \$50,000 (Plus up to \$15,000 to Cal-Breds) FOR FILLIES AND MARES THREE -YEARS OLD AND UPWARD WHICH ARE NON-WINNERS OF EITHER \$7,500 OTHER THAN MAIDEN, CLAIMING, OR NON-WINNERS OF TWO RACES.

Three-Year-Olds .....	118 lbs.
Older .....	122 lbs.
Non - Winners of a race other than maiden or claiming allowed .....	3 lbs.
of a race other than claiming .....	5 lbs

Six And One-Half Furlongs

As part of CTBA'S & TOC'S program to encourage the development of quality Cal-Breds, the \$15,000 (30% of the purse) is the maximum "incentive money" in this race awarded to a Cal- Bred finishing 1st-5th. A Cal-Bred\* placing 1st-5th will receive an additional 30% of their purse, as follows:

Claiming Price \$62,500 for each \$2,500 to \$55,000 .....	1 lb.

One Mile And One-Sixteenth (Turf-Chute)

As part of CTBA's plan to also improve the Cal-Bred program, the \$5,500 from the "Cal-Bred Owners Incentive Fund" will be awarded in it's entirety to a Cal-Bred sired by a registered California Stallion winning this race. Such a Cal-Bred would receive \$27,500 (55% of the purse) plus up to \$5,500 (20% of winners share of the purse) for a total of \$33,000. A Cal-Bred not sired by a registered California Stallion will receive 10% of the winners' share, or \$2,750. **Questions? Call TOC (626) 574-6620 or CTBA at (626) 445-7800.**

## **SCALE OF JOCKEY FEES:**

### Section 1632 of the CHRB's Rules and Regulations:

**JOCKEYS' RIDING FEE.** Jockey riding fees in the absence of a contract or special agreement, shall be:

Gross Purse	Winning Mount	2nd Mount	3rd Mount	Losing Mount
\$100,000 and up	10% of Win Purse	5%	5%	105.00
50,000-99,900	10% of Win Purse	5%	5%	80.00
25,000-49,900	10% of Win Purse	5%	5%	65.00
15,000-24,900	10% of Win Purse	5%	5%	55.00
10,000-14,900	10% of Win Purse	5%	5%	50.00
4,000-9,900	10% of Win Purse	65.00	50.00	45.00

The purpose of this rule is not to set a minimum or a maximum fee, but merely to provide a fee in the event that the parties have not made any other written agreement to the contrary.

All fees shall be payable in the lower purse range until the higher purse range is reached, unless there is a written agreement to the contrary.

A jockey's fee shall be considered earned when the jockey is weighed out by the clerk of scales. A fee shall not be considered earned if the jockey elects to take himself off of his mount; provided, however, that in the event of a substitution of jockeys after the fee is considered earned, no additional jockey mount fee or double jockey mount fee need be paid except when so ordered by the stewards.

For the purpose of this section "Win Purse" means the amount paid the winning horse less the fees paid by the owner to enter the horse in the race.

In the event the parties reach an agreement with respect to the fee to be paid the jockey, a contract or agreement in writing signed by the jockey or his agent and the owner or his authorized agent specifying the agreed upon fee in the event of a winning mount, 2nd place mount, 3rd place mount and losing mount shall be delivered to the paymaster of purses prior to the running of the race in question.

The paymaster of purses shall debit the owner's purse account in accordance with provisions of the contract or written agreement. If no contract or written agreement is submitted to the paymaster of purses prior to the running of the race in question, the paymaster of purses shall debit the owner's purse account in accordance with the fee scale set forth in this section which is to apply in the absence of a contract or written agreement between the parties.

No jockey shall share in the riding fees of another jockey.

### **NOTICE TO OWNERS & TRAINERS:**

Owners and trainers when entering horses in races are cautioned to check carefully the eligibility of their horses and the allowances claimed in all races. Under the universal rules of racing, an owner or trainer is responsible for the eligibility and the weight the horse carries. The Racing Secretary or any member of his staff will be glad to give horsemen any information in respect to their horses that is desired, but the final responsibilities rest with the owners and trainers.

A horse which wins a "Non-winner of \$7,500 other than maiden or claiming for California-Breds" shall remain eligible for that comparable open allowance race. Once a horse has won the two first-condition allowance races (California-Bred and Open), then the California-Bred win will be disregarded in future allowance races for eligibility purposes only.



## RULES OF RACING - SPECIAL NOTICE:

The following sections have been added to the Business and Professions Code: Section 19668.

(a) On and after July 1, 1995, it shall be unlawful for any person to enter or accept the entry of a horse in a race upon which there is pari-mutuel wagering until 2 years after the horse's foaling date.

(b) Every person who violates this section is guilty of a misdemeanor. The board may suspend the license of any person who violates this section for a period of not more than 1 year. Section 19407.6 "Foaling Date" means the date the horse is dropped by a mare as stated on the papers of registration. Do not enter two-year-olds until they comply with the above guideline.

No entry will be received except upon the condition that all disputes, claims and objections arising out of the racing or with respect to the interpretation of the conditions of any race shall be decided by the Stewards, and their decision upon all matters shall be final.

At the Stewards discretion and without notice, the entries of any person may be refused.

The stewards reserve the right to withdraw or scratch any horse which, in their opinion, will not qualify for the race in which it has been entered.

All horses to be entered in Cal-bred Races must first be registered as such with the California Thoroughbred Breeders' Association prior to the time of entry for such race. Cal-bred races if not filled by 9:30 a.m. may be opened up to non-Cal-breds with the original entries having preference.

A horse shall be carded in no more than one race in any one racing day, other than for a stakes race.

No more than 2 horses of the same interest or from the same trainer shall be entered in any race except a sweepstakes, an overnight sweepstakes or a divided race.

In all races at the distance of 1 mile on the main course, the field will be limited to ten (10) horses except in handicaps or sweepstakes. If management considers it inadvisable for any reason to run a scheduled race on the turf course, it will be run a corresponding or designated distance on the main track.

No horses will be worked out further than the distance of the race without the permission of the Stewards.

ELIGIBILITY AND ALLOWANCE. "Closed races" are considered as those restricted to "**Non-Winners of three races of \$7,500 other than Maiden, Claiming or Starter,**" or less (Non-winners of two races other than maiden or claiming, etc.) Overnight Stakes with conditions of Non-winners of three or less will also be considered a closed race.

The clause "Races when entered for ... not considered" applies to both eligibility and allowances unless otherwise qualified.

Allowances must be claimed at time of entry, and these allowances shall not be waived except by consent of the Stewards.

For the purpose of deciding which races are Sweepstakes in determining eligibility, the standards of the Jockey Club Statistical Bureau, Lexington, KY, shall be considered official.

## **CHRB RULE 1751 - OBJECTIONS TO A HORSE**

Objections to the participation of a horse entered in any race shall be made to the stewards and confirmed in writing by the objector. An objection to a horse entered in a race shall be made not later than 1 hour before the scheduled post time of the race in which such horse is entered, except that the stewards upon their own motion may consider an objection until such time as the horse becomes a starter.

### **STARTER ALLOWANCE RACES:**

Starter Allowance races will be written during the 2005 Bay Meadows race meet in the following categories: \$6,500, \$12,500 and \$40,000.

The \$6,500 and \$12,500 Starter Races will be for horses which have started for either of those respective claiming prices within a certain time period.. (Horses claimed will have to re-establish eligibility by running for the new owner at the prescribed level or less. Horses sold privately will retain their eligibility.)

\$40,000 Starter Allowance races are for horses that have started for \$40,000 or less and have not won two races of any kind.

Maiden Allowance preferences: Non-Starters for a claiming price of \$16,000 or less in the last three (3) starts preferred. This preference super-cedes date preference.

Starter races shall be considered the same as Claiming races, except where the conditions state to the contrary. Starter races will not be considered as claiming races in regards to preference clauses.

### **TRACK OPERATIONS:**

The track will be open between the hours of 5:30 a.m. and 10:00 a.m.

Per CHRB Rule #1689 and 1689.1, approved safety helmets and vests shall be worn during training periods and live race periods. Galloping or Ponying of horses the wrong way on the track is not permitted.

In an effort to better maintain and preserve the turf course for the racing season, it will be necessary to limit turf workouts to those horses scheduled to run in Turf Stakes only. Workouts need to be scheduled with the Racing Secretary. No ponies will be allowed to accompany horses for workouts.

### **TURF SHOE POLICY:**

ONLY QUEENS PLATES OR FLAT SHOES, FRONT & BACK WILL BE ALLOWED.

## CLAIMING PROCEDURES:

Horses must be claimed in accordance with full registered ownership. If there be two or more owners of a horse through which a claim is made, all must be included in the claim and so recorded thereon.

1651. ELIGIBILITY TO CLAIM. In claiming races any horse is subject to being claimed for its entered price by any racing interest, by any licensed horse owner, or by any person who has established his qualifications to claim by filing an application for license as horse owner and having been granted an Open Claim Certificate authorizing the claim. Such Open Claim Certificate shall not be issued until all conditions and qualifications for a horse owner's license have been met or completed.

UNLICENSED PERSONS. An individual who desires to become an owner of a race horse through claiming may request an Open Claim Certificate from the Stewards by the following method:

1. Submit a completed Application for Horse Owner's License to the California Horse Racing Board at the meeting where the Claim will be made. The application must indicate the breed of the horse to be claimed and must state "To be Claimed". The applicant must have the name of a licensed trainer who will be responsible for the care of the claimed horse. In addition to the application, a financial statement, a completed fingerprint card, and a check or money order for the license fee (\$250.00) are required.
2. The application will be processed and will be returned by the Board to the Stewards with a final recommendation. Upon approval, the Stewards may issue an Open Claim Certificate. When the Certificate is exercised, a Horse Owner's license will be issued. An Owner's license is not issued prior to the claim.

CLAIMING. All Claims must be deposited in the claiming box at least 15 minutes before post time or the time fixed for the race to begin and not later, and no official of said Association shall give any information as to the filing of claims therein until the race has been run. All claims shall be passed upon by the Stewards, or their designated representatives. When a claim is filed, it is irrevocable and at the risk of the claimant. For a period of 25 days after the claim, a horse shall not start in a claiming race for a price which is less than 25% more than the price at which it was claimed. The day claimed shall not count, but the following calendar day shall be the first day and the horse shall be entitled to be entered whenever necessary so that the horse may start on the 26th calendar day following the claim, for any claiming price. This provision shall not apply to Starter/Handicaps in which the weight to be carried is assigned by the Handicapper.

Re: Claiming Rule #1663. -- A claimed horse shall not be eligible to race in any state other than California until **60 days after** the close of the meeting where it was claimed, except in a stakes race.

NO FEE CLAIM CERTIFICATES will no longer be necessary. A horse can be claimed by any owner licensed in California or by holders of OPEN CLAIM CERTIFICATES.

## HORSEMEN'S BOOKKEEPER:

(650) 573-4565

The Paymaster of Purses office is open 3 hours prior to first post and until after the last race on racing days to transact business with horsemen. Current addresses and social security numbers for all owners and trainers must be submitted to the paymaster of purses pursuant to IRS Statute, Section #6676: Failure to include correct information on a return or statement has a penalty per failure. This penalty applies to the omission of information as well as to the inclusion of incorrect information. No purse money will be available until cleared by California Horse Racing Board.

The Paymaster of Purses does not keep ownership percentages in partnership accounts on file.

Owners and Trainers are required to deposit jockey fees with the Horsemen's Bookkeeper before a horse starts in a race.

## **STATE LICENSES:**

Under the rules and regulations of the California Horse Racing Board, all participants in racing, officials, owners, trainers, jockeys, stablemen, etc., as well as pari-mutuel operators are required to be licensed to serve in their respective capacities. This is handled at the track office of the Board functioning at each meeting; such licenses being valid from date of issuance and furnishing uniform identification for those actively engaged in the conduct of a race meeting.

All owners and trainers must be licensed and insured before entries of their horses may be made. If in doubt, please check at the office of California Horse Racing Board. Owners already licensed who have made a change of trainer are required to see that the insurance is properly adjusted in view of such change. Worker's Compensation must be in effect before horses arrive at Bay Meadows or any auxiliary stabling areas.

The California Horse Racing Board office is open on all racing days from 7:00 A.M. until 3:30 P.M. Licenses may be applied for and renewed. Full information on workmen's compensation is also available at this office. Trainers are required to maintain an updated list of all employees. Validation stickers are required for each employee. Stable employee lists are available at the Stable I.D. office.

Trainers are requested to check and amend their list of all stable employees in order that their current license cards may be validated. Validations are available at Stable I.D. office from 8:30 A.M. to 3:30 P.M. on race days.

The designated entrances must be used. Access to the grounds is only permitted through designated gates. Entering the grounds without authorization is trespassing and violators will be prosecuted.

## **VETERINARIAN'S LIST:**

**ATTENTION TRAINERS!!! C.H.R.B. Rule #1866**

All horses placed on the Vet's List will stay on the List for a minimum of Five days, and they will remain on the Vet's List until the Official Veterinarian or his agent removes such horses from the List. Horses are not removed from the Vet's List automatically.

Horses will be placed on the Vet's List for the following reasons:

1. Sick: The horse will be placed on the Vet's List for five days and will be ineligible to enter until the sixth day after placement on the Vet's List. Blood is not required.
2. Injury: Horse will be on Vet's List for five days and will be removed from the Vet's List the sixth day after placement on the List, upon demonstration that the injury has healed to the Official Veterinarian or his agent. A blood sample may be required.
3. Lameness, Sore, Broke-down and Unsound Horses: Horse is on the Vet's List for a minimum of five days, then horse must work a satisfactory 5/8 of a mile (published), and demonstrate racing soundness in the presence of the Official Veterinarian or his agent. Post-work blood sample will be taken. Drug levels may not exceed those allowed on day of race.
4. Bleeding Post-Race: Horse is placed on List for 2 weeks. Then the horse will be required to work 5/8 mile without bleeding for the official Veterinarian or his agent. The next time the horse bleeds visibly, the horse is placed on the List for 30 days. The third time, horse will not be eligible to race.
5. Exhaustion: The horse is placed on the Vets List for a minimum of five days and will be required to work 5/8 of a mile in the presence of the Official Vet or his agent and demonstrate improved physical fitness. A blood sample will be taken. Drug levels may not exceed those allowed on day of race.
6. Coggins: Horses shipped from out of State are required to have a current negative Coggins test within the last six months. Blood must be taken. Negative Coggins is required to remove horse from the Vet's List.

1842. VETERINARIAN REPORT. Every veterinarian who treats a horse within the enclosure shall, in writing on a form prescribed by the Board, report to the official veterinarian in a manner prescribed by him, the name of the horse treated, the name of the trainer of the horse, the time of treatment, and any other information requested by the official veterinarian. Any such report is confidential and its content shall not be disclosed except in a proceeding before the Stewards or the board, or in exercise of the Board's jurisdiction.

C.H.R.B. RULE 1847. BLOCKING OF LEGS OR ANKLES: The blocking of the nerves in a horse's leg or ankle by injection or by the use of any local anesthetic or other means with the exception of ice is prohibited at any time on a day when such horse is to race.

### **SUMMARY OF MEDICATION RULES:**

#### **BLEEDERS**

It is the responsibility of the trainer to see that the bleeder status of the horse is correct on the horse's foal certificate. When a horse is put on the bleeders list or taken off the bleeders list the papers should be in the racing office where the meet is running. If foal certificates are not in the office, or are removed before they are stamped, the trainer must bring them to the State Veterinarians office to be updated. Treatment with lasix is permitted 4 hours prior to post time with 5 cc lasix I.V. only. Premarin may be given at 4 hours prior to post time. Yellow detention stall sign must be posted at time of treatment.

#### **PERMITTED MEDICATION:**

Only one of the following substances may be given no less than 24 hours prior to post time and must be reported to the Official Veterinarian by 12:00 noon of race day. The allowed levels in post race test samples are indicated:

Phenylbutazone: 5 mcg./ML, Banamine (Flunixin):20 nanogram/ML, Ketoprofen 10 nanogram/ ML. All other substances are either improper or prohibited substances when found in a post race test sample and may not be given after entry time.

#### **ADMINISTRATION OF RULE 1850:**

It is the responsibility of anyone registering horses to report a heel nerved horse. The Racing Secretary shall be responsible for seeing that the registration paper discloses the fact that the horse has been nerved. The information shall be recorded on the face of the registration certificate showing the date and the name of the Veterinarian. The Racing Secretary shall be responsible for notifying the Veterinarian representing the State of all heel nerved horses registered. In the event that a horse on the grounds is to be heel nerved, permission first must be secured from the Veterinarian representing the State.If approval is granted, the Veterinarian representing the State should notify the Racing Secretary in order that the fact may be recorded on the certificate.

#### **ATTENTION HORSEMEN & VETERINARIANS!!**

**ALL HORSES REQUIRING BLEEDER MEDICATION MUST BE TREATED ON THE GROUNDS AT BAY MEADOWS FOUR OR MORE HOURS PRIOR TO THEIR POST TIME. FURTHER ALL OTHER HORSES MUST ARRIVE NO LATER THAN TWO HOURS PRIOR TO FIRST POST. THERE WILL BE NO EXCEPTIONS.**

**BY ORDER OF THE CHR B**

All horses receiving **Shockwave Therapy** must be reported to the Official Veterinarian. Those horses will be placed on the Shockwave Therapy List and will not be allowed to start for 10 days.

Track is entitled to perform physiological tests consisting of the taking of blood samples from owners' horses entered into races to be conducted at the Race Meet. Such samples will be tested for bicarbonate levels. Trainers of horses showing a total carbon dioxide per liter of plasma in excess of the level specified in the Race Meet Agreement (s) between the Track and the Thoroughbred Owners of California or The California Thoroughbred Trainers shall be subject to the disciplinary measures specified in such Agreement.

Effective immediately, only water shall be used for "mouthwashes". The mouthwashes shall not contain any other substance, including flavoring agents. Any horse that has been administered a mouthwash other than water on race day shall be scratched from the race in which it is entered. In addition, a CHR B complaint will be filed against the trainer of record for violation of CHR B regulations (including but not limited to Rules 1843 and 1843.5).

## PREFERENCE DATE SYSTEM:

All horses whose foal certificates are registered with the Racing Secretary on the first day of entries, Friday, December 23, 2005 will receive an entry date for that day. Thereafter, horses will receive entry dates for the day their foal certificates are registered with the Racing Secretary. Such entry dates will be good for any category.

1. In all races, winners are preferred.
2. Maidens will not be eligible to receive an entry date in any race until their papers are on file with the racing office at the time of the draw. Entry dates for maidens are good for any maiden race.
3. Horses which are drawn into races and horses on the also eligible list which draw into races, will receive a running date corresponding to the date on which they are to run, and lose all dates previously held.
4. Horses on the Veterinarian's, Stewards' or Starter's list cannot establish a date. They will not be permitted to enter until they have been approved to start. Horses placed on these lists will keep their dates if they ran in the particular race in which they made the list. Horses which are scratched and placed on a list will be given a scratch date for the day of that race.
5. In all cases, an entry date takes preference over a running date of the same day and a running date takes preference over a scratch date of the same day.
6. Horses drawn on the overnight (either in the race or on the also eligible) which scratch, will lose their date and acquire a scratch date corresponding to the day of the race, unless otherwise specified by the Stewards. Any horse on the also eligible list that is declared will retain its preference date if the scratch is not activated. Other scratched horses will be treated in the following manner:
  - a. Runaway in the Paddock-Entry date for day of race.
  - b. Runaway in the Post Parade-Entry date for day of race.
  - c. Flip in the gate prior to the start-scratch date for day of race.
  - d. Scratched for insufficient works-scratch date for day of race.
  - e. Scratched because of incorrect markings-scratch date for day of race.
  - f. Ineligible to race in which drawn into - scratch date for day of race.
  - g. Scratched because of breakdown in transportation to the track-Retains original date.
  - h. Scratched at the gate and not put on any list-scratch date for day of race.
  - i. Entered in the wrong race by delegated agent or trainer-scratch date for day of race.
  - j. Horse hurt in gate due to accident involving another horse retains original date.
  - k. Horse left behind the gate-Retains original date.
7. Horses which have established a date at the current meeting will lose that preference date should they race elsewhere.
8. Stakes races are not considered in the preference date system.
9. In no way does the claiming, ownership transfer or trainer transfer of a horse affect the preference date.
10. Maidens when entered in a winners' race will retain original date. Trainers must declare at time of entry when entering a Maiden in a winner's race.
11. Horses entered will initially receive an entry date corresponding to the date on which they are entered.
12. A Same-Owner entry cannot exclude a single entry except when race preferences indicate otherwise. Trainers must declare at time of entry if he/she has a Same-Owner OR Different-Owner entry in the race. All Same-Owner entries must have a declared first and second choice at entry time.
13. An "In-today" entry cannot exclude another entry except when race preferences indicate otherwise. An "In-today" entry can exclude a second-choice Same-owner entry or a maiden in a winner's race.
