The Greenvale Town Board met Aug 21, 2007 at 8:00 p.m. at the town hall with all members present except Robert Winter.

Chairman Richard Moore called the meeting to order and the pledge was said.

Clerk proceeded to read the minutes from July. Bernard Budin moved to accept Richard Moore second. Approved.

Minutes from extended annual meeting were read and Bernard Budin moved to accept and Richard Moore second. Approved.

Commissioner Joe Harris stepped in to say hello and ask if any questions or concerns. Joe commented that the \$50,000 grant that the Association of

Townships Dakota Co put in for was granted by the Mt Council and also \$25,000 from C.D.A. This was given to Dakota Co. to aid townships in doing the 2030 Comprehensive Plans. There is a general plan plus each township has an application to their own area.

320th is still in the plan but is in the waiting stage again. If Northfield does the ring road and adds Barrett Avenue, maybe some federal \$'s involved and Dakota would do both projects at same time when equipment is here.

Kristine Hanson came in for a permit for a 16x16 porch & deck to be added on to her house. Plan is not approved yet. Bernard Budin moved to accept and Richard Moore second. A permit can be issued when plan approval is in without coming to another meeting.

David Lawrence came for a permit for a 40x40 pole shed for equipment. Bernard Budin moved to accept Richard Moore second and permit was written.

Landy Knutson came in for a permit for a 45x96 pole shed which he will use for storage and a shop area. He

Eric Christenson had some papers as to legals for land and such, will take to attorney.

Greg Langye asked about putting minutes on line. Donovan Prescott said he could scan existing minutes and did not need to be typed. Also put agenda on line. Need agenda items one week in advance.

CapX 2020 has been sending letters for putting up new lines. Bev Tapp from Eureka Township has contacted Rick Len regard to getting more information out to public. She gave Rick a resolution asking this to be an agenda item at the fall meeting of Dakota Co. Association of Townships.

Richard Moore moved to sign this resolution and send to Marilee Kothari secretary of Assoc of Twpes. Bernard Budin second. Approved.

Received a letter from Charlene Klemenhagen asking if township would donate money to Brexvale Cemetery. Has heard some townships are doing this. Board discussed and said since a church is in charge we have never done this in past. Methodist church in Castle Rock takes care of records.
