7 FURLONGS. (1.21) STAKES. Purse \$250,000 DEL MAR FUTURITY (GRADE I) FOR TWO-YEAR-OLDS (FOALS OF 2005). By subscription of \$250 each if made on or before May 30, 2008, the fee to accompany the nomination. For horses not nominated, supplementary nominations of \$10,000 each will close at the time of entry, Sunday, August 31. All horses shall pay \$500 to pass the entry box and \$2,000 additional to start, with \$250,000 Guaranteed, of which \$150,000 to first, \$50,000 to second, \$30,000 to third, \$15,000 to fourth and \$5,000 to fifth. Weights: colts and geldings, 123 lbs.; fill ies, 120 lbs. Non-winners of \$50,000 twice allowed 2 lbs.; of such a race, 4 lbs. of \$25,000 other than maiden or claiming, 6 lbs.; of a race other than claiming, 8 lbs. High weights preferred. Total non-claiming purse earnings will determine the order of preference for horses of equal status. A trophy will be presented to the owner of the winner. Nominations closed Friday, May 30, 2008, with 259. Supplementary nominations closed Sunday, August 31, 2008, with 5. (Clear 78)

Chestnut Colt, (Mar), by Unbridled's Song - Fleet Lady by Avenue of Flags. Trainer Baffert Bob. Bred by Stonerside Stable(KY). MIDSHIPMAN stalked off the rail then outside, went three deep on the turn and rallied under urging to get up late. CORONET OF A BARON had speed between horses then stalked off the rail, bid three deep into the stretch, gained a short advantage, drifted out in the final furlong and held on well but was caught late. STREET HERO chased between horses then three deep into and on the turn and into the stretch, angled inward past midstretch and closed willingly inside. SOUTHERN EXCHANGE went up inside to duel for the lead, fought back on the turn, came a bit off the rail in the stretch and continued willingly but was outfinished. BELIEVE IN HOPE chased outside then four wide into and on the turn and into the stretch and bested the others. ESCALON bobbled slightly at the start, chased outside then between horses on the turn, came three deep into the stretch and could not summon the necessary late response. BLAZING SPIRIT settled off the rail, angled in leaving the backstretch and improved position in the stretch. WILD WILD POSSE saved ground chasing the pace on the backstretch and turn and lacked the needed rally. KERWIN'S WAY dueled three deep, dropped back between foes on the turn and weakened. KELLY LEAK had good early speed and dueled between horses on the backstretch and turn and weakened in the stretch. Mенса HEAT chased between horses then a bit off the rail leaving the turn and had little left for the stretch.
