## NOTICE OF PROPOSED ACTION

August 27, 2008

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, the Nevada Administrative Code (NAC) Chapter 445B, and the Clean Air Act, the Division of Environmental Protection is issuing the following notice.

The Administrator received an application to issue an operating permit (renewal) for a Class I facility from the following applicant:

Nevada Power Company - Sunrise Generating Station P.O. Box - 98910 MS 30 Las Vegas, Nevada 89151-0001

The project is located in southern Nevada, Las Vegas, Nevada in Clark County. The physical address of the facility is at 6300 Vegas Valley Drive, Las Vegas, NV 89122. The Administrator has prepared tentative determinations regarding the operating permit that, in brief, are the following:

One steam generating boiler; one cooling tower; and one fuel oil storage tank. The emissions from the facility will be 799.93 tons/yr of  $PM_{10}$ ; 3,242.75 tons/yr of  $PM_{10}$ ; 106.17 ton

Adverse ambient air quality impacts are not expected.

On the basis of the preliminary review and the requirements of the NRS, the NAC and the Clean Air Act the Administrator is hereby announcing his intent to issue a Class I air quality operating permit (renewal) based on a review of the information, as proposed. The application, draft permit, any comments received, and other relevant information may be copied at the above address or copies may be obtained by requesting in writing at the above address. Written comments or objections, will be received at the Nevada Division of Environmental Protection, above address, until October 2, 2008, and will be retained and considered prior to final action on the Class I operating permit. Upon a valid written request received prior to the end of the comment period, the Administrator will schedule a public hearing on the application and proposed action.
