PUBLIC NOTICE OF PROPOSED ACTION Web Posting Date - 02/19/09

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes. The Administrator has received a complete application for renewal of water pollution control discharge permit (NEV2003305) from the following applicant:

Elko County Public Works 155 South 9th Street Elko, Nevada 89801

The applicant operates the Bear Creek Water Treatment Plant near Jarbidge, Nevada. The permit is for the discharge of filter backwash water from the filtration plant to groundwater via an infiltration trench. The plant is located on Bear Street in Jarbidge, Elko County, Nevada. Latitude: 41°52'23.65"N.; Longitude: 115°26'17.31"W. in Section 17, T.46N., R.58E. MDB&M.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes (NRS) as amended, and implementing regulations, the Administrator proposes to reissue the permit to discharge, subject to certain effluent limitations and special conditions. The proposed permit is for a five (5) year period.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication notice. However, the Administrator can, by this notice or with discretion, extend the comment period. All materials being submitted must be hand-delivered, e-mailed, faxed or postmarked no later than 5:00 P.M. PST, or PDT if in effect, on Monday, March 23, 2009, the close of noticed comment period, to:

The request must be filed within the comment period as noticed and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received by 5:00 PM up through the comment period date, as noticed herein or as extended by the Administrator, will be considered in the formulation of final determination

regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
