PUBLIC NOTICE OF PROPOSED ACTION

The Administrator, Division of Environmental Protection, Carson City, Nevada is issuing the following notice of proposed action under the Nevada Revised Statutes and Federal Water Pollution Control Act. The Administrator has received a complete application for a water pollution control discharge permit (NEV2009502) from the following applicant:

Sparks, Nevada 89431**

The applicant proposes to supply and manage tertiary treated, denitrified, and disinfected effluent for construction water, irrigation, and dust control in Sparks at a total of five, present and planned, City of Sparks truck fill stations. Currently, two fill stations operate under separate permits: Sha Neva (#NEV2004530) and Truckee Meadows Fire Department Station #4 (NEV95005). Future fill stations include one at Kleppe Lane and two at locations to be determined. The consolidation permit (NEV2009502) addresses permit conditions for the current and future effluent reuse truck fill facilities. The Permittee will continue the use of effluent from the Truckee Meadows Water Reclamation Facility (NEV2003506) for the subject truck fill stations in accordance with conditions in the approved Effluent Management Plans required by the Nevada Division of Environmental Protection, and by the terms and conditions of the permit.

On the basis of preliminary review of the requirements of the Nevada Revised Statutes (NRS) as amended, and implementing regulations, the Administrator proposes to issue a permit to discharge, subject to certain effluent limitations and special conditions. The permit for this facility will include sampling requirements to assure maintenance of the state ground water quality standards. The permit will be issued for a five (5) year period.

Persons wishing to comment upon or object to the proposed determinations by the Administrator regarding permit issuance, or request a hearing pursuant to the Nevada Administrative Code, Water Pollution Control, should submit their comments or request, in writing, within thirty (30) days of the date of newspaper publication notice. However, the Administrator can, by this notice or with discretion, extend the comment period. All materials being submitted must be hand-delivered, e-mailed, faxed or postmarked no later than 5:00 P.M. PST, or PDT if in effect, on Monday, March 23, 2009, the close of noticed comment period, to:

The request must be filed within the comment period as noticed and must indicate the interest of the person filing the request and the reasons why a hearing is warranted. All comments or objections received by 5:00 PM up through the comment period date, as noticed herein or as extended by the Administrator, will be considered in the formulation of final determination regarding the application. If written comments indicate a significant degree of public interest in the proposed permit, the Administrator shall hold a public hearing. A public notice of such hearing will be issued not less than thirty (30) days prior to the hearing date.

If no hearing is held and the determinations of the Administrator are substantially changed from the tentative determinations, the Administrator will give public notice of the revised determinations. Additional comments and objections will be considered at that time.
