## A NOTE FROM SENATOR HARRY REID

Dear Fellow Nevadan,

Nevada's economy is struggling and our families and businesses are paying the price. Our unemployment and foreclosure rates are among the country's worst. As you know, Congress passed and President Obama recently signed a historic \$787 billion economic recovery package. The main purpose of the American Recovery and Reinvestment Act (ARRA) was to create the jobs that will put Americans back to work and get our economy back on track.

In order to help Nevadans to take advantage of the ARRA, I assembled this Resource Guide to the American Recovery and Reinvestment Act of 2009, which compiles information on many federal programs and funding opportunities available to individuals, communities and businesses in Nevada.

Under this legislation, Nevada will receive \$1.5 billion in direct aid and Medicaid assistance, as well as millions more in competitive grants that collectively are expected to create and save nearly 34,000 jobs in our state. It is critical that our families, businesses and municipalities have the information they need to access these funds as quickly as possible.

## Child Care and Development Block Grant (CCDBG)

*\$2 billion was included for the Child Care and Development Block Grant (CCDBG) program.*

## The Emergency Food and Shelter Program

*\$100 million was included for the Emergency Food and Shelter Program*

## Child Nutrition School Equipment Grants

*\$100 million was included for the School Equipment Grants Program*

## Title IV-E Foster Care and Adoption Assistance

*\$1.04 billion was included for Title IV-E Foster Care and Adoption Assistance.*

Nevada will receive \$5.0 million in federal matching funding for state expenditures on Title IV-E Foster Care and Adoption Assistance. To be eligible for this increased funding, states must maintain their Medicaid eligibility standards, methodologies, and procedures as they were in effect on July 1, 2008.

## State Fiscal Stabilization Funds

*The State Fiscal Stabilization Fund provides \$53.6 billion to provide fiscal relief to states.*

---

Nevada will receive \$396,582,797 in stabilization funds.

**Agency:** U.S. Department of Education

**State Administrator:**

Office of the Governor, Nevada Department of Education

**Description:** To provide fiscal relief to the States to prevent tax increases and cutbacks in critical education and other services. To provide funding for elementary, secondary, and higher education, and for public safety and other government services, including higher education modernization.

The Governor may use 81.8% of the stabilization funds (\$362.78 million) to support elementary, secondary, and postsecondary education and some school construction and 18.2% of the stabilization funds (\$80.7 million) for public safety or other government services, which can include education and higher education modernization, renovation, and repair.

*\$12.2 billion was included for the Individuals with Disabilities Education Act (IDEA).*

## Education Technology

*\$650 million was included for the Enhancing Education through Technology program.*

**Description:** The Enhancing Education through Technology program supports State, district, and school efforts to integrate technology into curricula in order to improve teaching and learning. Funding shall be used for technology hardware, software applications, professional development and related instructional technology staff and services. These funds should be used to improve student academic achievement and ensure that students are college and workforce ready by ensuring that every student has 21st century skills and is technology literate. In addition, the funds should be used to increase ongoing and meaningful professional development around technology that leads to changes in teaching and curriculum and improves student achievement.

## Vocational Rehabilitation

*\$540 million was included for Vocational Rehabilitation State Grants.*

<b>Description:</b>	This program provides grants to states to support a wide range of services. Eligible individuals are those who have a physical or mental impairment that results in a substantial impediment to employment, who can benefit from vocational rehabilitation (VR) services for employment, and who require VR services. Priority must be given to serving individuals with the most significant disabilities if a state is unable to serve all eligible individuals.

## Teacher Quality Enhancement Competitive State Grants

States may use grant funds to reform teacher licensing and certification requirements; provide alternative methods of teacher preparation; and provide alternative routes to State certification. The funds provided in the economic recovery bill will assist States in modernizing the teaching workforce, address teacher shortages, and provide new routes to teaching for jobless individuals seeking to enter the teaching field.

<b>Description:</b>	To make competitive grants to States to enable them to design and develop statewide longitudinal data systems that use individual student data for reporting and improving student achievement and to facilitate research to improve student achievement and close achievement gaps. With these grants, states could increase the capacity of their data systems, provide teachers the information they need to tailor instruction to help each student improve, and give administrators the resources and information to effectively and efficiently manage their data systems.
