



Application for admission into the Voluntary Cleanup Program of the Nevada Division of Environmental Protection must be made on the following form approved by the Administrator of the Division. Only typewritten or computer generated applications will be accepted. The Administrator will approve or deny any application within 60 days unless for good cause he extends the period for not more than an additional 30 days. If the Administrator denies an application, he shall deliver a written explanation to the applicant within 30 days after the denial. If the Administrator denies an application for any reason other than incompleteness the applicant may apply to the State Environmental Commission to review the decision.

III. SITE ASSESSMENT

An application for admission into Nevada's Voluntary Cleanup Program will not be considered complete without an attached Phase I site assessment of the property. This assessment must include information regarding property ownership, current property use, proposed property use, and all written communications with regulatory agencies that relate to the environmental condition of the property. Other required information includes

a) a legal description of the property;

b) a description of the physical characteristics of the property;

c) to the extent known by the applicant, the operational history of the site;

d) to the extent known by the applicant, information concerning the nature and extent of any contamination or release at the eligible property; and

e) to the extent known by the applicant, relevant information concerning the potential for human and environmental exposure

to contamination at the property.

Within the attached site assessment, the applicant may also provide any additional information specific to the eligible program that the applicant deems appropriate. The Nevada Division of Environmental Protection may also request additional information before the application is considered complete.

The applicant is free to decide the format of the Phase I site assessment, but its contents must include the information listed above and must be attached as Attachment A.

IV. FUTURE USE OF PROPERTY

An application for admission into Nevada's Voluntary Cleanup Program will not be considered complete without the submittal of information regarding a proposed general plan for removal or remediation on the property. This plan must contain information regarding the intended future use of the property and how any remedial actions will achieve this goal. This proposed plan is not to be considered a remedial agreement with the State. Acceptance of this application by the Division does not authorize the undertaking of any remedial actions outlined in this proposed plan.

V. PROGRAM APPLICATION FEE

A person submitting an application for admission into Nevada's Voluntary Cleanup Program must submit a nonrefundable application fee along with their application form. Application fees are based on the use and size of the property and have been set at the following rates:

Residential	\$400
Commercial	
Less than 1 acre	\$500
1 to 25 acres	\$1,000
26 to 100 acres	\$1,600
More than 100 acres.	\$2,000

Commercial properties include all properties not considered residential, i.e. industrial and commercial. Commercial application fees apply for undeveloped land contaminated as a result of unregulated activities.

Payment of application fees will only be accepted in the form of a check payable to "State of Nevada--Division of Environmental Protection/VCP". An application form will not be considered complete without the attached application fee.
