OPENING OF PARLIAMENT

The Dewan Ra'ayat met at 10 a.m. pursuant to the Proclamation of His Majesty the Yang di-Pertuan Agong. The Clerk read the Proclamation:

"PROCLAMATION

by

His Majesty the Yang di-Pertuan Agong, By the Grace of God of the States and Territories of the Federation Supreme Head

Whereas it is provided by Clause (1) of Article 55 of the Constitution of the Federation that We shall from time to time summon Parliament:

Now therefore We, Tuanku Abdul Rahman ibni Al-Marhum Tuanku Muhammad by the Grace of God of the States and territories of the Federation Yang di-Pertuan Agong in exercise of the powers conferred on Us as aforesaid Do Hereby summon Parliament and appoint the eleventh day of September, 1959, at the hour of Ten in the forenoon as the date and time for the First Meeting of the First Session of the First Parliament of the Federation, to be held in the Tunku Abdul Rahman Hall in Our Federal capital in Kuala Lumpur.

Given at our Istana Negara in Our Federal capital of Kuala Lumpur, this 27th day of August, 1959".

ELECTION OF SPEAKER

The Prime Minister (Tunku Abdul Rahman Putra Al-Haj) stood up, and addressing himself to the Clerk of the House (who, standing up, pointed to him and then sat down) said: I propose that Dato' Haji Mohamed Noah bin Omar do take the Chair as Speaker of this House. (*Applause*).

Dato' Teoh Chze Chong (Segamat Selatan): I have much pleasure to second the motion.

Whereupon the said Dato' Haji Mohamed Noah bin Omar was conducted to the Chair by the Prime Minister and Dato' Teoh Chze Chong.

Mr. Speaker sat down in the Chair.

The Prime Minister (Translated from Malay): Mr. Speaker, Sir, on behalf of the House I would like to express my heartiest congratulations to you, Sir, on your election as Speaker of the House. On behalf of the House and Members of this Parliament, I would like to say that I am confident that with your knowledge of the procedure and all other matters pertaining to the Order of this House, you will be able to carry out your duty effectively; and it is my conviction that all Members of this House have the fullest

confidence in you, Sir. I do not intend to be elaborate in my speech, but I would wish, on behalf of the House, to offer you once again my heartiest congratulations.

Dato' Onn (Kuala Trengganu Selatan) (*Translated from Malay*): Mr. Speaker, as I find that there is no letter to Members to say that there will be no speeches to congratulate you, it would be well if an opportunity is given to the parties on this side of the House to offer their congratulations as, in my view, the Honourable the Prime Minister should not rise to offer congratulations on behalf of the whole House. He can only do so on behalf of Members on the Government side, and not on behalf of the whole House unless the agreement of all sections of the House has first been obtained.

Mr. Speaker (*Translated from Malay*): Honourable Members, the Standing Rules and Orders of the House have not been approved yet, but to accord with normal practice, it is proposed that Members be given an opportunity to make speeches to congratulate the Speaker, although this is not mentioned in the letters addressed to Members. Any Member who wishes so to speak may do so now.

The Minister of Interior (Dato' Suleiman) (*Translated from Malay*): Mr. Speaker, I suggest that Members wishing to congratulate the Speaker should confine themselves to speeches of congratulations.

Dr. Burhanuddin (Besut) (*Translated from Malay*): Mr. Speaker, on behalf of my colleagues I would like to congratulate you, Sir, on being elected as Speaker of this House. We hope that under your guidance the House will henceforward function in an orderly manner, bringing about the welfare and prosperity of the country, which is the aim in having this Assembly constituted.

Mr. D. R. Seenivasagam (Ipoh): Mr. Speaker, Sir, I rise to offer to you, on behalf of the representatives of the Peoples Progressive Party of Malaya and of the representative of the Malayan Party sitting here, our sincere congratulations.

Mr. Speaker, Sir, from the Opposition point of view sitting here, the prerequisite for the proper function of parliamentary democracy is, in the first place, the election of a Speaker who will discharge his duties with dignity and absolute impartiality. I am sure that in you, Mr. Speaker, we have these essential qualities.

On behalf of the Members of my Party and the Member of the Malayan Party, I once again join in offering to you our sincere congratulations.

Dato' Onn (*Translated from Malay*): Mr. Speaker, I rise to associate myself with the speeches of congratulations made by the Prime Minister, the Pan Malayan Islamic Party, the P.P.P. and the Malayan Party. I was surprised to hear just now a Minister of the Government suggesting that the speeches should be confined only to congratulations. I have no doubt that you, Sir, are familiar with the rule of procedure that a member making a speech of congratulation may also be permitted to express his views, briefly, if we desire the House to be conducted on the principles of democracy.

I wrote to the Clerk of the House asking whether members would be permitted to make speeches of congratulations. And his reply was that there would be no such speeches to avoid possibility of a controversy. We see that your election has been unanimous. I merely wish to express my views to you, Sir, and to Honourable Members because the composition of this House is not quite the same as that of the former Legislative Council in that here we have an opposition on this side, comprising about one third of the total number of members of the whole House. I would like to say that although members of the opposition are only about a third of the whole, I hope in any debate in this House it should be remembered that this one third represents 46 per cent of the total electorate at the recent Federal Election.

This House is not quite the same as the previous Legislature as we now have an opposition which, I believe

will make for healthy debates. Speaking for myself I can give you an assurance. This is because I have heard of the apprehension expressed in some quarters that the opposition will merely oppose. As a matter of fact it is not going to be so. The aim of the opposition is to offer constructive criticisms. That is what I have in mind. However, although I have given this assurance, it should not be thought that I will always be at one with everything that is desired by the Government.

You, Sir, have the necessary experience and you were a member of the Legislative Council of the Persekutuan Tanah Melayu and of the Johore Council of State, a fact which prompts me to support your election as Speaker. But, Sir, I would like to give my views on this matter for your guidance because in my opinion—I too had the honour to sit in Councils such as this—an essential quality that a Speaker of an assembly such as this should have, especially now when we have various parties here—the Government and the opposition—is first tolerance—more than tolerance—when called upon to consider any point raised in the House. Likewise a Chairman or Speaker is expected to give an impartial ruling regardless of whether the matter is raised by a member on the Government side or by the opposition. I have no doubt that you, Sir, are conversant with this aspect of the matter and will be fair to every section of the House.

Mr. Chin See Yin (Seremban Timor): Mr. Speaker, Sir, I rise to speak not only for myself but for my two Independent colleagues in this House. We wish to congratulate you on your election as Speaker of this House, and we are confident that you will surely discharge your duties fairly and justly in the interests of the people of the country.

Mr. Speaker (*Translated from Malay*): Honourable Members, I would like first and foremost to thank the Honourable the Prime Minister, the Honourable Member for Besut, Dr. Burhanuddin, the Honourable Member for Ipoh, Mr. D. R. Seenivasagam, the Honourable Member for Kuala

Trengganu, Dato' Onn, and the other Honourable Member for their speeches congratulating me on my election and welcoming me as the first Speaker of the first Parliament of the Federation of Malaya.

I regard my election as a great honour, and in that light I accept it with pleasure, intending thereby to place my services at the disposal of our community, state and religion. I fully appreciate the high responsibility of this office, but the unanimous vote of this House is a clear manifestation of the confidence Honourable Members have in me. I shall uphold that confidence.

I am confident Honourable Members of this House will give me their constant support, help and co-operation in the discharge of my onerous duty as Speaker. For my part, I shall always endeavour to the best of my ability to uphold the dignity of this high office and do my best to ensure good order in the House and to safeguard its honour and good name.
