#### **IP 641 Nonproliferation in the NIS**

The seminar will provide an overview of the issues surrounding the proliferation of nuclear, chemical, and biological weapons and ballistic missiles in the former Soviet Union. Particular emphasis is on Russia as a nuclear weapons state and also the state with the bulk of Soviet nuclear, chemical, and biological infrastructure, and also a state that is actively engaged in both military and civilian applications of nuclear power. Considerable time will be spent on Central Asia. The course will emphasize the interrelationship between nonproliferation regimes and political and economic developments – both domestic and international and explore the impediments to the strengthening of WMD nonproliferation. The interaction between NIS states and three issues key to global nonproliferation will be covered in detail: Iran, North Korea, and South Asia.

Students are expected to have basic knowledge of existing WMD nonproliferation regimes prior to taking this class. If you have problems, check CNS tutorials at <a href="http://www.nti.org/h\_learnmore/h3\_tutorial.html">http://www.nti.org/h\_learnmore/h3\_tutorial.html</a>.

### Students are required to write three papers:

- (1) policy memo (3-5 pages) submitted on October 4 on a politically relevant aspect of any theme covered by that time. If in doubt about the choice of the topic, consult the teacher. The memo should contain analysis of the problem and realistic recommendations on policy changes/initiatives designed to solve that problem.
- (2) no later than November 20, all students are required to attend on seminar at CNS (these are usually held at lunchtime) and submit a summary of the topic, main arguments, approach, findings, and conclusions of the speaker. The summary should be no longer than one page.

(3) research paper (10-15 pages) due on November 22 on a politically relevant aspect of WMD nonproliferation, whether covered or not covered in class. The overall design is similar to that of the memo, but analysis and recommendations are expected to be more comprehensive and researched in greater depth. Research papers will be presented in class (students writing on similar topics are allowed to give joint presentation). Each presentation will be no more than 5-7 minutes with 10-15 minutes discussion afterwards.

<u>Readings</u>. Students are expected to complete readings before coming to class. There are no books for purchase; most readings are available on the Internet, the rest from reserve at the library. Students are also encouraged to do their own research and bring additional materials to class.

All students are required to browse relevant sections of CNS databases – country profiles (<a href="http://www.nti.org/e\_research/profiles/index.html">http://www.nti.org/e\_research/profiles/index.html</a>) and nonproliferation databases (<a href="http://www.nti.org/e\_research/e7\_databases.html">http://www.nti.org/e\_research/e7\_databases.html</a>) prior to class.

Grading: policy memo -10 percent, seminar summary -5 percent, research paper -20 percent, presentation of research paper -10 percent, participation in class -50 percent, remaining five percent awarded at discretion of the teacher for brilliance (95 percent will still get you an A).
